- 2. <u>Title. Good and merchantable vehicle title is part of this agreement and must be attached hereto.</u> In the event title is encumbered by assignment, pledge, chattel mortgage or security agreement, consignor shall present with their agreement written consent of the holder of such security interest to sell such vehicle and the minimum price for which such security interest will be released. (Vehicle must be in Auction Company hands prior to the Auction).
- 3.. I assume all risk loss, liability and damage incident to or arising out of vehicle left on Auction's premises and I shall provide insurance for such loss, liability and damage.
- 4. With respect to each and every vehicle delivered by me to the Auction for sale, I represent to the Auction and to the buyer of that vehicle that:
 - a) The vehicle is in a safe condition to operate on the public highways and complies with applicable laws, including laws relating to safety, performance and environmental standards;
 - b) I will fully and accurately disclose the description, condition, known defects and mileage of the vehicle and be solely responsible for such representatives;
 - c) I am the true and lawful owner of vehicle;
 - d) I have good and right power to sell the vehicle;
 - e) I agree to pay to the Auction such fees as the Auction rules/policies provided for any vehicle which goes through the Auction but is not sold. I specifically grant to the Auction a possessor lien against any such vehicle for which a fee is due as security for the payment of such fee.
